**Sub.: Anchor Investor details in the proposed initial public offering ("IPO") of L&T Finance Holdings Limited (the "Company")**

The Company has filed a Red Herring Prospectus with the Registrar of Companies, Mumbai, Maharashtra ("RoC") on July 15, 2011 for IPO of Equity shares of face value of Rs 10/- each, for cash aggregating upto Rs. 12,450 million following the book building process.

The maximum amount available for allocation to Anchor Investors is Rs. 1612,500,000 being 30% of QIB portion. The Company has finalized an allocation of an amount of Rs. 1,530,496,800 to Anchor Investors.

The IPO committee of the Company in its meeting held on July 26, 2011 has finalized the following allocation to Anchor Investors - aggregating to 27,330,300 equity shares at a price of Rs. 56 per equity share (including a premium of Rs. 46 per share).
