Rationale

Considering the TTM Sep -25 EPS of Rs 59.24 on a post issue basis, the company is set to list at a P/E of approximately ~37x with a market cap of Rs 1,07,007 Cr whereas its peer namely HDFC Asset Management Company Ltd, Nippon Life India Asset Management Ltd, UTI Asset Management Company Ltd and Aditya Birla Sun Life AMC Limited are trading at P/E ratio of approximately ~40x, ~39x, ~24x and ~22x respectively.

We assign a 'Subscribe' rating to this IPO as the company is the largest asset management company in India in terms of assets managed under active mutual fund schemes and equity and equity oriented schemes. Also, it is available at a reasonable valuation considering the growth potential of the company.

Company Overview

ICICI Prudential AMC Ltd is the largest asset management company in India in terms of active mutual fund quarterly average assets under management ("QAAUM") with a market share of 13.3% as of September 30, 2025

As of September 30, 2025, their total mutual fund QAAUM was ₹10,147.6 billion.

They offer a comprehensive suite of investment solutions across Mutual Funds, Portfolio Management Services (PMS) and Alternative Investment Funds (AIFs), covering diversified products such as equity and debt schemes, ETFs and index funds, arbitrage, liquid and overnight schemes, multiple PMS strategies including Contra, PIPE, Growth Leaders, Value, Large Cap and ACE, as well as Category II and III AIF offerings that cater to the sophisticated allocation needs of HNI and institutional investors.

They manage the largest number of schemes in the mutual fund industry in India as of September 30, 2025, with 143 schemes comprising 44 Equity and Equity Oriented Schemes, 20 debt schemes, 61 passive schemes, 15 domestic fund-of-funds schemes, one liquid scheme, one overnight scheme and one arbitrage scheme

As of September 30, 2025, they have established a pan-India distribution network comprising 272 offices across 23 states and four union territories. Their distribution model is targeted to be balanced and multi-channelled, encompassing both physical and digital platforms, and is supported by our salesforce. As of September 30, 2025, their mutual fund distributors ("MFDs"), consisted of 110,719 institutional and individual MFDs, 213 national distributors and 67 banks (including ICICI Bank Limited).

They have a pan India geographical presence serving customers directly in more than 23 cities across 14 states and two (2) union territories with a network of 25 branches as of June 30, 2025.

Strong September: ₹48.03 Billion Systematic Inflows

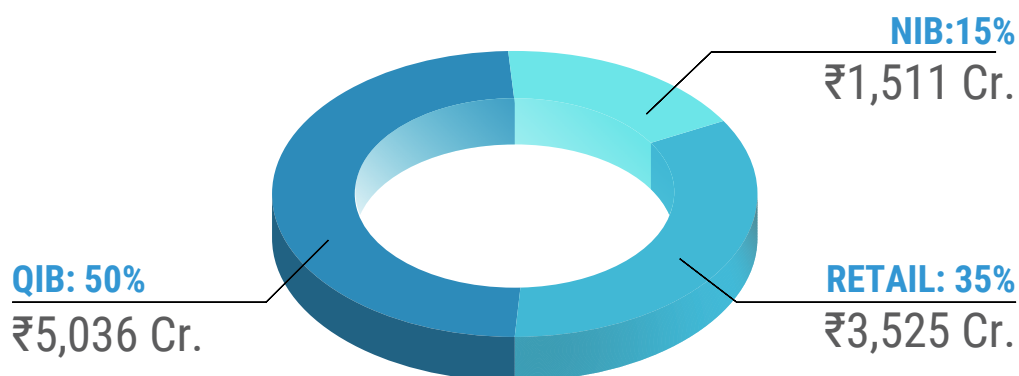

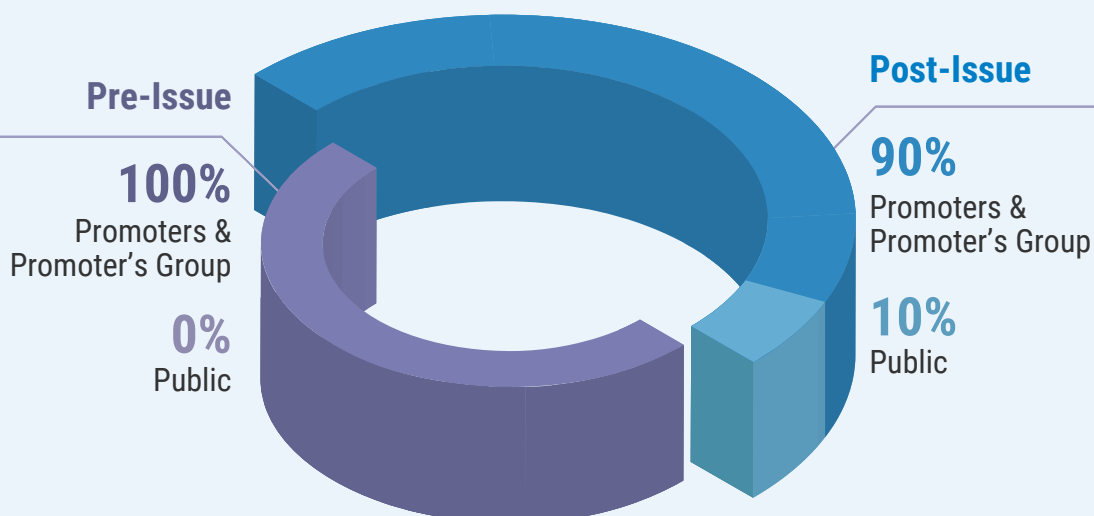

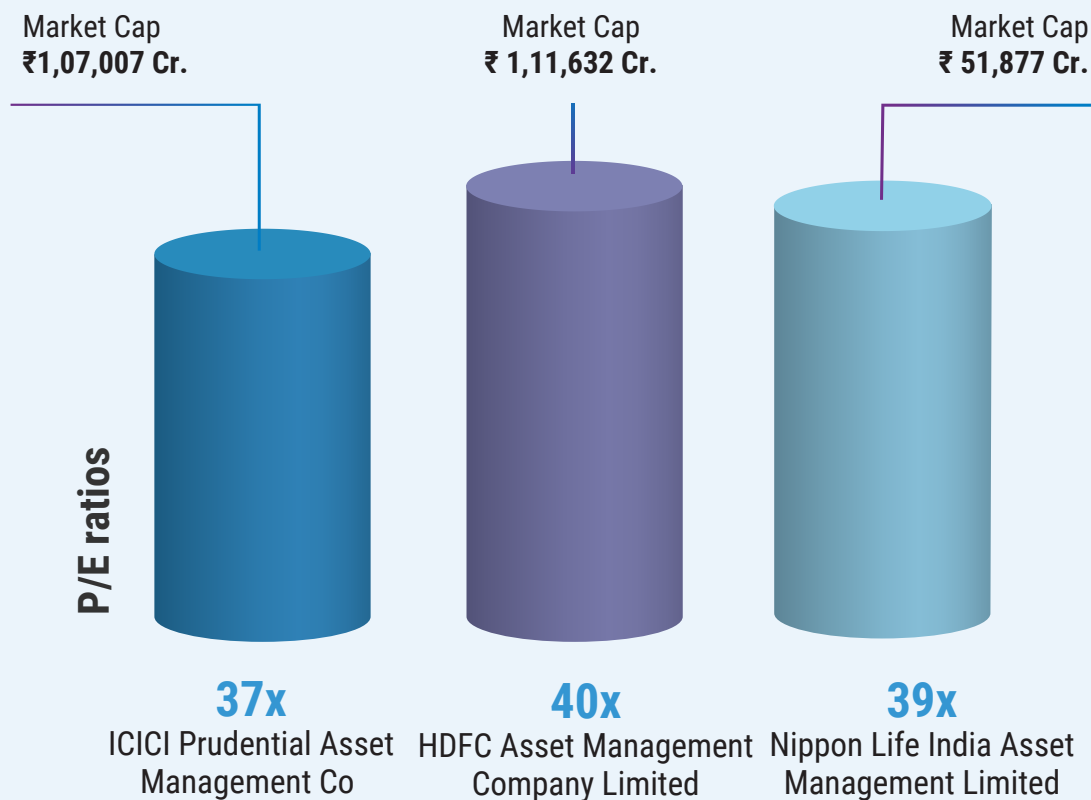

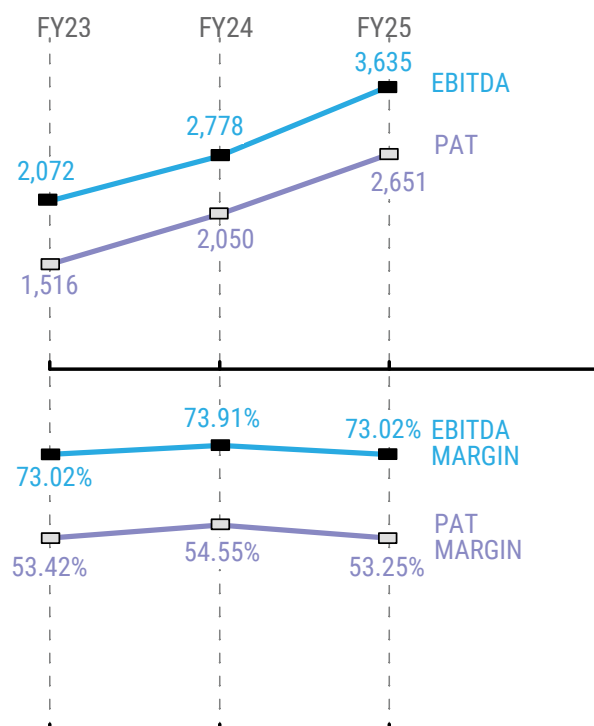
