Poised for Growth in India's Expanding Grade A Office Market

Knowledge Realty Trust (KRT), formed in October 2024 and backed by Blackstone and Sattva, is a Mumbai-headquartered REIT with 30 Grade A office assets totaling 48.1 msf (37.1 msf completed), 90% committed occupancy, and a WALE of 8.6 years. The portfolio includes marquee properties like One BKC, Sattva Knowledge City, and Cessna Business Park, along with 4 ROFO assets offering 7 msf of development potential.

As of September 30, 2024, KRT's GAV stood at INR59,400 crores, with FY26 projected NOI of INR4,300 crores and an expected 18% CAGR through FY27. One World Center has 57 tenants with 65.8% rentals from domestic corporates, while One Qube's occupancy rose to 77% in December 2024. Over 450 blue-chip tenants across BFSI, IT/ITeS, and GCC sectors ensure steady cash flow.

Financials show total assets of INR24,971 crores (book value) and INR62,274 crores (fair value), with borrowings at INR19,948 crores, mostly floating rate and secured. H1 FY25 revenue was INR1,881.63 crores, with finance costs at 43.86% of total income. Post-listing, leverage is targeted below 21% of initial GAV, the lowest among listed Indian office REITs.

Capital commitments of INR813 crores include INR358.48 crores for Sattva Knowledge Capital and INR250.14 crores for IMAGE Tower, funded via internal accruals and selective debt/equity. Special Purpose Combined Financial Statements consolidate KRT and its Asset SPVs for IPO purposes, with certain pending acquisitions excluded from historical data.

With strategic locations, high occupancy, embedded rental growth, and a strong development pipeline, KRT is well-positioned to tap India's expanding Grade A office market. Sponsor strength, prudent debt management, and stable tenant mix underpin its potential for sustained distributions and capital appreciation.
